### 4 First Aid Measures

**Inhalation:**

If inhaled, remove to fresh air. If not breathing, give artificial respiration. Seek medical attention if breathing problems develop.

### 7 Handling and Storage

**Precautions for Safe Handling:**

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. **Conditions for Safe Storage:**
